- Victoria County Challenges implementation challenges in Victoria County, and available options for Victoria County;
- Contracts Existing contracts and the implications of altering the collection system;
- Program Cost Currently there are too many unknown variables to accurately estimate costs;
- Partnership Potential to continue to operate with J.S. Bellis as a recycling facility, and/or as a transfer station only.
- Recycling Facilities Are there other recycling facilities in Maine or Nova Scotia where we could send our material if J.S. Bellis is not interested?
- Provincial Facility Has the Province looked at a Provincial facility?
- Public Survey The committee requested staff to prepare a public survey in order to gage public interest in the possibility of curbside recycling to be reviewed at the next meeting.

### Summary:

Overall the committee felt the objective was not to save money, but to offer the public the best possible service. The committee decided the next step is to conduct a meeting with Peter Morin of J.S. Bellis to determine if the company has any interest in becoming a recycling facility or contracting as a recycling transfer station. That decision will determine what further investigations will be required from staff. The best case scenario would be J.S. Bellis is interested and we can work together to develop the recycling program; however, if that is not the case the committee will be required to explore other options.
